The Agri-Food Act, 2004

The Beekeepers Development Plan Regulations Order 04/09 CHECK-OFF COLLECTION

The Saskatchewan Beekeepers Development Commission, pursuant to the provisions of *The Beekeepers Development Plan Regulations* and The Agri-Food Act, 2004 hereby determines:

- 1. a. That by May 31st^t of each year, each beekeeper who has 100 or more colonies in production shall remit a check-off of \$1.00 per colony in production, to the Commission.
 - b. All colonies mentioned in 1(a) that are in production on July 1st of each year will be subject to the check-off.
- 2. By May 31st of each year, any beekeeper who has less than 100 colonies in production may remit a check-off of \$1.00 per colony in production, to the Commission.
- 3. This order will remain in effect for a period no longer than 10 years beyond the date this order is approved by the Council.
- 4. Order No. 01/06 Check-Off Collection, of the Saskatchewan Beekeepers Development Commission is hereby wholly revoked (and Order No. 04/09 replaces Order No. 01/06).

Due to the Dec. 2, 2016, majority vote by the SBA membership to merge with the SBDC, and to facilitate the levy collections for the 8 month transition year, which takes the place of what would have been the 2017 SBA registration fee, the SBDC board requests that levies for the transition year Jan.1, 2017-Aug 31, 2017, be remitted by Jan. 31, 2017 and we further request that refunds for the transition year be submitted no later than March 15, 2017.

All beekeepers in the province with 100 hives or more are mandated by legislation to register with the commission. Provision has been made for non-beekeepers, as well as beekeepers with less than 100 hives to register with the commission. See the attached form:
