SBDC Call for Elections & SBDC Director Nomination Form

Overview of election/nomination procedure:

1. Every registered producer is eligible as a nominator and as a nominee. You must have registered with the SBDC on or after September 1, 2018 to be eligible and be a member in good standing.
2. Two Directors will be elected for a three year term.
3. You must be present at the AGM to vote.
4. Every registered producer who registers for the AGM will be provided with a ballot form.
6. Each nomination submitted must be signed by two registered members (your registration status will be confirmed by the SBDC Administration office and the returning officer).
7. The profile page must be filled out in its entirety.
8. Nominations must be received by the deadline date shown below.
